Narrative

On 06/02/2020 at approximately 1645, I Officer O. Tellez P# 17964, along with Officer P. Mills P# 15850, both operating as marked patrol unit 3G11, were dispatched to the location of 5451 Mesa Dr, Las Vegas, Nevada, 89110 (County, G3), in regards to a assault/battery with other deadly weapon call. The details of the call stated that a female had been run over by a vehicle and also stabbed by her boyfriends ex-wife. The following officers were also dispatched:

T. Palmer P#18287, C. Hearrell, J. Ramos P#18017 and B. Sink. P#16389.

Upon arrival, officers made contact with Bridget Kearns, DOB [REDACTED], who identified herself verbally. Palmer interviewed Bridget who stated the following: At approximately 1646 hours, Bridget arrived at her home located at 5451 Mesa drive, Las Vegas, NV 89110. Bridget stated that she witnessed the suspect, who was later identified via her NV DL card as Diana Aguayo DOB [REDACTED] which is her current boyfriend's ex-wife, drive up to Bridget's residence. Diana was being verbally aggressive toward Bridget's daughter Kyra. Bridget approached Diana, who was still seated in her own vehicle, which at that point Diana put her own vehicle in drive and "floored it" hitting Bridget, dragging Bridget into her own house wall, pinning her against the wall. Bridget was able to escape between the vehicle and the house wall and approached the driver side door in order to remove Diana from the driver seat and restrain her until officers arrived. As Bridget was attempting to restrain Diana, Diana pulled out a straight blade knife and stabbed Bridget in her left arm and the left side of her chest. Bridget immediately let go of Diana and Diana then fled the area in her vehicle.

I, Tellez, interviewed Leonardo Esquivel, DOB [REDACTED], who lives with Bridget, his girlfriend of 2 years, at 5451 Mesa Dr. Leonardo stated that at approximately 1645 hours, he and Bridget were driving to their home. When Leonardo arrived home he observed his ex-wife Diana in a black 2018 Dodge Charger in front of his house. Leonardo pulled next to Diana and stated that if she wanted to arrive at his residence she needed to contact her lawyer because they were instructed in divorce court to stay away from each other. Leonardo then parked his truck in his driveway and Bridget approached Diana as she was inside her vehicle. Bridget was on the roadway when Diana placed her vehicle in reverse and then drove forward. Leonardo grabbed Bridget and began escorting her into their residence. Diana then drove her vehicle onto Leonardo's front yard striking and Bridget and Leonardo. Bridget was dragged across the north/ east portion of his yard, and finally pinned between the east wall of his home and Diana's vehicle. Bridget was able to move between the wall of the residence and Diana's vehicle and proceeded to walk towards Diana's vehicle. Bridget reached into through the vehicle, and attempted to remove Diana from the vehicle. While Bridget was grabbing Diana, Diana

gripped a "dagger" and stabbed Bridget. Bridget then let go of Diana and Diana fled the area. Leonardo added that the "dagger" was pulled from what appeared to be a yellow hair comb as if to be disguised as a comb instead of a dagger.

I spoke with Kyra Kearns DOB [REDACTED] (daughter to Bridget), who verbally identified herself, and she stated that approximately 1640 hours she confronted Diana in front of the residence of 5451 Mesa Dr. Kyra got into a verbal altercation with Diana and admitted to officers that she threw rocks at Diana prior to Leonardo and her mother arriving at the residence. The rocks thrown were described as small pebbles which struck Diana's face.

I spoke with Hunter Mynear, DOB [REDACTED] (boyfriend to Kyra), who identified himself via his NV ID card. Hunter stated to officers that he hit Diana's vehicle with a baseball bat during Diana's verbal altercation with Kyra. Hunter admitted to officers that he damaged Diana's vehicle by breaking the front passenger window.

Shortly after fleeing the scene, Diana did call for police assistance requesting to provide information of the incident.

Diana stated to Officer Hearell that she went to the residence of 5451 Mesa Dr, in order to take pictures of her vehicle that was on Leonardo property. Diana claimed she was physically attacked by Kyra, who threw rocks at her. Diana added that Hunter then smashed her passenger door window with a bat. Diana stated that she was attempting to leave when Leonardo arrived and tried to "corner" her. Diana stated Bridget was attacking her from the driver side window by pulling Diana's hair. Diana placed her vehicle in drive and drove forward striking the east wall of the residence. Diana drove away after striking the wall. Diana stated that she did not stab Bridget and denied striking Bridget with her vehicle. Diana claimed to not have a knife.

I Officer Tellez, observed a hole on the east wall of the residence of 5451 Mesa Dr approximately four feet wide by four feet tall. I also observed tire marks stretching from the west side of Wind River road to the east/north portion of the yard indicating that a vehicle had recently driven into the front yard of 5451 Mesa Dr. There is an average height sidewalk curb between the public roadway and 5451 Mesa Dr. A large pool of blood was observed by the front entrance area of the residence (where Bridget was located by officers upon arrival). The front portion of Diana's vehicle had substantial front end damage, specifically the front right side portion. The front passenger side window was shattered and several dents were observed on Diana's vehicle that are consistent to Hunters admission that he damaged Diana's vehicle.

Officer Palmer observed a stab wound to the left side of Bridget's chest as well as a stab wound to Bridget's left forearm. Bridget had multiple scratches and bruises to her left knee, left elbow, feet, and her back.

I was able to review surveillance footage from the residence of [REDACTED]. The footage showed Diana inside her vehicle facing southbound on Wind River, facing the curb, Leonardo and Bridget were to the left of the vehicle walking westbound through their front yard toward their residential entrance. Diana then put her vehicle in reverse as Leonardo and Bridget were walking. The video surveillance clearly shows Diana turn her vehicle to the west to directly face Leonardo and Bridget. Diana then drove her vehicle forward with a rate of speed fast enough to drive up the steep curb and accelerate forward striking both Bridget and Leonardo and pinning Bridget to the east wall of the residence.

Medic West 525 transported Bridget to UMC, where she received stitches for her stab wounds and was later released.

Due to the fact that Diana did use unlawful force and violence, resulting in substantial bodily injury to Bridget by striking her with a vehicle, which is a deadly weapon when used to drive into people, and by stabbing Bridget in her left forearm and to the left side of her chest with a straight blade dagger style knife, Diana is in violation of NRS 200.481.2e and is being charged with Battery with a Deadly Weapon

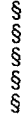

**Narrative**

Leonardo Esquivel came into Enterprise Area Command to report the following incident:

Esquivel owns two vehicles-a white 2006 Chevrolet Cobalt NV/589C23 which was parked at 863 Teal Ave and a black 2008 Dodge Charger NV/LVU4V9, which he had parked at 3890 Graphic Center Dr (apt 2067). Esquivel states he was staying at 3890 Graphic Center on Sunday 2/10/2019 and his 2008 Dodge Charger was parked in the parking lot of the complex. Esquivel left for work on Monday 2/11/2019 around 0700 hours and the vehicle was fine and had no damage. Esquivel states he arrived back to the apartment from work around 1400 hours and found all four tires slashed and flat. Esquivel went and spoke to Adam, who is the downstairs neighbor who lives at #1065, and Adam told Esquivel he saw the whole incident. Adam told him a female pulled up in a black Dodge Charger around 1030 hours, exited and slashed all four tires on his Dodge Charger and then the woman had a brief conversation with him. Adam has never met suspect but after describing her, Esquivel suspected it to be his wife, whom he is in the middle of going through a divorce.

Esquivel states after he saw the tires slashed, he drove over to 863 Teal Ave to check on his other vehicle. Esquivel found the Chevrolet Cobalt with all four tires slashed and flat along with the word "BITCH" carved on the drivers side door. There is also etching in the glass windshield where suspect tried to carve in the glass. Esquivel immediately went over to the neighbors house across the street to see if his video cameras picked up any suspect footage of the incident. Per video, it shows his wife Tiana Aguayo driving up in her black Dodge Charger and parking in front of the next door neighbors house, exiting the vehicle and approaching the white Chevrolet Cobalt. Tiana bends down and appears she is tampering with the tires and walks all the way around the vehicle. It is unclear what she used, but video clearly shows her damaging all four tires and marking on the drivers side door of the vehicle. Tiana then gets back into her vehicle and drives away.

Esquivel has the video on his cell phone.

Esquivel is also willing to prosecute. He was given an ACI and will return it with with either an estimate or receipt of repair for both vehicles.
